Chief LaBelle – 1) Burn ban will remain in effect until we receive measurable rain. 2) We will be participating in the homecoming parade. 3) Thank Mandy and Brendan Boyer for school presentations during fire prevention month. 4) There will be an appreciation dinner for first responders at the Oddfellow

Hall on October 20. 5) Cleaning up items to surplus. They will be moved to St. 93 for storage until disposed. 6) Administrative Assistant job will be posted on October 24. Discussion ensued as to whether or not this should be a combination position – administrative assistant/emergency responder. Chief LaBelle did remind the board of the expense of an emergency responder. It will be posted as administrative assistant only. (Sioux Ellis moved to proceed with administrative assistant only at this time and possibly proceed later with a combination position. Dykast seconded. Motion carried. (Yes – Brown, Dykast, Spence, Ellis. No – Traeger.) 7) A memorandum of agreement has been signed with Oregon Pacific. Scio will assist in educating the public with new CPR equipment. It is active until 2027. 8) AFG grant money for hoses and nozzles has been received. 9) Command vehicle is on its way by rail.

Administrative Assistant – Nothing at this time.

Volunteer Association -- 1) Halloween this year will have trick or treat stations for people to go through.
