Chief LaBelle – 1) Hose and Ladder Testing on 3/30 & 3/31. Company will come out and complete the testing for the new hose we received. 2) Thank you to our staff and board members who assisted with the Appreciation Event. We had a nice event with a good turnout. 3) Ford F-150 is now complete with a Tonto Cover. Lettering will be completed for the pickup on March 28th and should be ready for use. 3) We are still on track to receive the OSFM Fire Agency Outreach Investment \$10,000. 4) Three large "Fire Danger" signs will be coming for Scio Fire, Crabtree and Bilyeu Den. This was donated to us by the State. 5) April 8th is the Easter Egg Hunt that the Fire Fighters will be putting on.
