### STAFF REPORTS:

Chief LaBelle – 1) Generator for St. 91 has been leaking oil and will need to be fixed. The Ford V10 generator also has a cracked block. A new engine block is needed since there is not a warranty on it. A new engine block pricing starts around \$5,000-\$7,000 approximately. Peterson CAT will send us a bid for the new engine block. 2) Windows have been tinted with UV protection in St. 91. 3) The new Ford F150 2022

Pickup Truck had lights installed at Wireworks. 4) St. 91 has received 513 calls in 2022. 5) We have officially switched over from Firehouse Reporting System to ESO. We have reported all calls to the Fire Marshalls office. 6) We have received 92% of all property taxes. 7) Appreciation Banquet will be held on March 11th at Boulder Falls. We will be covering Jefferson the week before and they are covering us during this event. 8) Kori Sarrett from Accuity will be here on Feb 21st to do our audit.

Administrative Assistant - Nothing at this time.

Volunteer Association -A.I.C. Nicholas Riedel is with the SCBD Association (Scio Crabtree Bilyeu Den). This group will be meeting every other month starting in January. The next meeting will be held in March. The SCBD Association will help support the Spring sports teams for the school district. Chief LaBelle will update the Job Announcement to reflect the new desirable starting date and application deadline. The posting date will be from February 15th 2023 to March 15th 2023.
