We will have an Apparatus Operator and Firefighter to respond on a Type 6. The daily staff will respond on calls as well as other assigned duties around the three stations. 2) Lt. Owens acquired a \$10,000 VA grant for wildland equipment.

Sheila Forster – 1) Audit will be July 28. Volunteer Association -- Nothing at this time.
