CORRESPONDENCE: Scio community member Allen Ralston passed away and asked that donations be made to the Scio Fire District. Allen and his family supported the fire district with donations for feed the boot and canned goods for the Christmas basket program. We received a \$100.00 donation from Chuck and Donna Baird in memory of Allen. Eloise Peaslee made a \$25.00 donation to the district.

STAFF REPORTS:

Chief White -1) We will surplus two transport vehicles and have purchased 2013 GMC Yukon for \$13,000. We are in the process of transferring lights and putting lettering on the new vehicle. 2) Updating the organization chart to include a second Divion Chief. In the process of interviewing for the two Division

Chief positions. One of these is to replace Howard Ellis' position. 3) We now have seven new volunteers, which brings us up to 36 volunteers. The district has purchased new bunker gear for the additional volunteers 4) We applied for the AFG Grant and hope to hear back by April. This grant will be used to replace the SCBA's. 5) We applied for the OSFM Upstaffing Summer Grant and waiting to hear back. This grant will run July 1st-Sept 23rd. 6) Working with the Deputy Fire Marshall from Lebanon to conduct defensible space surveys. We can then train the volunteers how to complete these surveys during the Summer Grant 7) Capital project we are currently working on is the mini split for St. 92 8) Volunteer handbook is approved and distributed to the board members.

Administrative Assistant - Nothing at this time.

Volunteer Association - Randy Boyer - Easter Egg Hunt will be Saturday, March 30th and hosted by the SCBA. This event will be held at the high school and gates open at 9:30am.

OLD BUSINESS:

Public Comment on Stillman Investigation - President Dykast commented on the independent investigation that took place on September 2023. This investigation was in response to a medical call that occurred in September 2021. The districts lawyer received the results in February 2024. An executive session meeting occurred in February 2024 to discuss the results of the report. The board agreed upon sharing the summary of the report with the family of the subject.

Tiffany Stillman - The board members made the wrong choice in dealing with this situation and the former fire chief. She feels that the board needs to change.
