## **STAFF REPORTS:**

Chief LaBelle – 1) To date we have run three hundred calls. This is close to the same number as last year.

2) The audit is complete. It all looked good. The auditors said that the payroll should not be part of the information in a public meeting. Kori Sarrett will be here at a future meeting once audit is complete. 3) We

opened the Community Room as a cooling center during the hot weather. Two guests, Pumpkin and Latte, guinea pigs. The owners air conditioner broke down. 4) A 100-mile bike race was completed on the 14<sup>th</sup>. Darin Colgan and Steve Boros opened St. 92 as a rest area. On September 10 there will be a Bikes, Bridges and Brews with a 22-, 33-, and 44-mile bike ride. We will have a booth and also "rovers" covering the routes. 5) Lt. Owens has been working on clothing surplus. Once the hose has been reviewed for surplus, a resolution will be brought to the board. 6) Prospective Fire Chief is still in the background process due to a change in Ukiah fire and recordkeeping. Information has been received for completing background check. Physical is August 29. A date for a Special Meeting and Executive Session needs chosen. Board consensus was to meet on Wednesday, September 7 at 7 p.m.
